It consists of a total number of 13 digits, based on 11 codes included in 9 variables organised into 4 decision clusters, yielding 2 diagnoses.

It is based on Robins and Guze's paper, "The classification of affective disorders: the primary-secondary, endogenous-reactive and the neurotic-psychotic dichotomy," published in *Recent*

Advances in Psychobiology of the Depressive Illness, edited by Williams, Katz and Shield in 1972, in which depression was divided into primary depressive disorder and secondary depressive disorder. In revised CODE-DD primary depressive disorder is characterised by depressed mood, self-incrimination, loss of desire to live (suicidal tendencies), insomnia and decreased appetite (weight loss); and secondary depressive disorder by depressed mood, self-incrimination, loss of desire to live (suicidal tendencies), insomnia and decreased appetite (weight loss) in temporal connection with medical illness.
