PSYCHIATRIC DISORDER ENDOGENOUS DEPRESSION

It consists of a total number of 19 digits, based on 19 codes included in 12 variables organized into 5 decision clusters, yielding 1 diagnosis.

It is based on Taylor, Redfield and Abrams paper on "Neuropsychological dysfunction in schizophrenia and affective disease" published in *Biological Psychiatry* in 1981, in which endogenous depression is defined. In revised CODE-DD endogenous depression is characterized by anxious mood (depressed mood or dysphoria) with late insomnia, worst in the morning, decreased appetite (weight loss), agitation (motor restlessness or motor retardation), suicidal tendencies and feeling of guilt (feeling of hopelessness or feeling of worthlessness) in the absence of medical illness or substance use in temporal connection with the depressive syndrome.
