It consists of a total number of 34 digits based on 32 codes included in 13 variables organized into 6 decision clusters yielding 1 diagnosis.

It is based on Jules Angst's presentation at the XVIth CINP Congress in Munich (Germany) in 1988 and Angst, Merikanga, Scheidegger and Wick's paper, "Recurrent brief depression (RBD): a new subtype of affective disorder," published in the *Journal of Affective Disorder* in 1990, in which RBD is defined as a major depression which lasts less than two weeks and recurs once or more monthly for at least a period of one year. In revised CODE-DD, RBD is characterized by episodes of anhedonia (depressed mood, dysphoria or lack of interest) with decreased appetite (excessive appetite, weight gain or weight loss), hypersomnia (insomnia), agitation (motor restlessness, motor retardation or stupor), anhedonia (decreased sex drive or lack of interest), asthenia (feeling of loss of vitality), feeling of guilt (feeling of inadequacy, feeling of worthlessness or self-incrimination), disturbance of concentration (constricted thinking, indecisiveness or retarded thinking) and loss of desire to live (suicidal tendencies), which are of brief duration and frequent recurrence.
